# STATUTORY DECLARATION

I, \_\_\_\_\_, Consultant of \_\_\_\_\_ in the State of Queensland do solemnly and sincerely declare that :

1. I have met and know \_\_\_\_\_ and her six oldest children, \_\_\_\_\_, \_\_\_\_\_, \_\_\_\_\_ and \_\_\_\_\_, \_\_\_\_\_ and \_\_\_\_\_. I also know \_\_\_\_\_, but only through the evidence of the above persons and others, and court proceedings.
2. More than three years ago, Hetti Johnson of "Bravehearts' asked me if I would try to help \_\_\_\_\_. Hetti said to me : This is a woman I have been trying to help for six years with no success. Would you consider trying?" I said I would try and made contact with \_\_\_\_\_.
3. I have been a Civil Libertarian for exactly forty years to date and in 2004 I completed a law degree and a Bar Practice Course, thus qualifying to be a barrister. I was refused entry to the legal profession for no valid or adequate reasons by persons I have later learnt are not of good character. It is clear that I knew too much then about the web of corruption engulfing Australia then, but now, it is much worse and I know a lot more about it.

4. Right now, a paedophile magistrate has issued an arrest warrant for me and no one who is properly responsible to fix that idiotic bit of illegality has any courage to do it. I do not believe it is a coincidence that the warrant was issued when I was in this particular Magistrates court the day after the following occurred..

5. The Deputy Prime Minister, Warren Truss, acting on information I provided to him, wrote to the Bob French, the Chief Justice of the High Court asking him to file a Writ for another parent I am helping whose little son was by the Family Courts ordered to continue to live with his sexually abusive mother and her paedophile associates, despite eyewitness evidence of the mother sexually abusing the boy. The Writ submitted for the upteenth time was to correct the crass illegality of the Family Court processes and it was submitted pursuant to a section (75) of the Constitution which the High Court MUST file and deal with. However the High Court has been refusing to file such writs in clear contempt of the Constitution for at least 15 years. In particular to protect corrupt judges.

6. However, the net was closing in on the illegality in the High Court as I now have signatures from three of its judges confirming that they are contemptng the Constitution in aid of paedophiles and this was the issue that would have landed in Bob French's hands that Monday, February 3rd.
  
7. On Tuesday, February 4th the warrant for my arrest issued, instead of an acquittal for a trumped up charge of assault from \_\_\_\_\_, paedophile and multiple child murderer. Who does not like th enet closing inon him, either.

9. With [redacted]'s family, the material being supplied with this is largely self explanatory and much of it is supplied to corroborate what [redacted] stated on the DVD footage of him revealing what his father is like and how he knows who really murdered Daniel Morcombe. [redacted] and his siblings also, were compelled despite all evidence, to live with their in every way abusive father by the Family Court.

## Chronology

10. This footage of [redacted] was shot more than three years ago, Recently, he was bashed severely by 16 Victorian police officers who apparently thought it was open to them to do that merely because he was accused of something which they were arresting him for. As far as I know, he is currently in custody but publicity might protect him more than cause him more trouble .
11. Once I had this footage, I tried to get police to investigate the things [redacted] it evidences but they were disinterested,
12. It was submitted the the Crime and Misconduct Commission by someone acting on my behalf because they, too, were disinterested when I spoke with an officer there. No one wanted to know who killed Daniel Morecombe.
13. I arranged with a then retiring head of the homicide squad in the Victorian police to have him submit to the Queensland CMC this DVD of the interview I did with [redacted] for me, which he did. Then, after some weeks with no response, I rang him and asked

him to follow up. That week, the Queensland Crime and Misconduct Commission (“CMC”) was running radio advertisements asking for any member of the public who had

14. information they might be interested in to come forward and contact them. A couple of days later, the senior police officer from Victoria rang me back and said that the CMC had informed him, verbatim as follows : “We decided not to follow up that information because it did not come from a solicitor.”
  
14. Subsequently, I contacted Peter Boyce, the solicitor the Morecombe parents, Bruce and Denise were using on the Sunshine Coast. I spoke with him in person at some length then later, I delivered a copy of the interview in to his office, with a request that it be provided to the Morecombe's who at that time were residing in Tasmania.
  
15. About three weeks later, I telephoned Bruce Morecombe to check that he and Denise had the DVD. They did not. So I told Bruce about it and suggested that he should ask his solicitor for it.

16. Not long after that (I do not recall how long) the Daniel Morecombe enquiry was proceeding in Brisbane. I went there and found Bruce and Denise and had a brief chat. She asked me a bit about the DVD which by then they had a copy of and wrote down the names that I could tell her about and made sure she knew how the various names related to each other. Denise told me that a particular female police officer had been in close touch with them for several years, having been assigned to their case and that she was very nice.

17. My Evidence was that he had been shown a photograph of Daniel Morecombe's body. The enquiry was coming to an end soon with a final five day week of public hearings scheduled to happen at Maroochydore. I wanted to give the Evidence I had but was concerned that the photograph of the body (if it still existed) would disappear if I spoke of it in that hearing.

18. There was no way for me to get it, although I knew where it likely still was within the co-killer's home and where that home was. I decided that the only available solution was to see if the police would get a warrant and try to get the photo. I called the officer in

charge of the "Ethical Standards Division" at Queensland police headquarters.

18. He expressed interest in having a copy of the footage and I arranged to take him home the next day, being a Tuesday. I explained that I had a busy day and that I could get in to see him until at least 5 pm. He said that was fine, that he had people on duty then or later. In the event he telephoned me twice after 5pm and I got there to see him at 7pm. I had a friend with me. Two officers came down to see me and would not let my friend come in with me. I spoke with these two men for about 40 minutes and told them all that I could.
  19. One was a Detective Sergeant and the other was a Detective Inspector, both said to be from 'Ethical Standards.' Both were aged in their fifties. The senior Inspector said to me "It is more likely than not that that photograph still exists." I replied: "Yes, I have learnt a lot about paedophiles. They keep things like that as trophies – and to intimidate those around them, like their own children. I see that you have studied paedophile behaviour." He replied, "Yes, I have." At the end of the interview, this more senior man was very interested and he said to me very clearly: "I will call you in the morning." He never did.
  20. What actually happened that next morning – the Wednesday – was that a Deputy Commissioner of police travelled the 100 kilometres to Maroochydore in order to shut the enquiry down before lunchtime, two days early.

21. Of course, they knew from me that I was expecting to give my Evidence including the DVD interview with to the enquiry the next day. I had arranged with the Morecombe's solicitor to call me when he wanted me to appear, to give my evidence but he had not and did not call. I determined to go myself anyway, but gave the police the opportunity to get that photograph of Daniel Morecombe's body beforehand. (View the footage - there is more)
21. Subsequently, I offered that footage to the defence solicitors from Brett Cowan, the man accused of Daniel Morecombe's murder. They were not interested in having a copy.
22. I know how overwhelmingly corrupt lawyers are. Most of them will do anything to just keep getting lots of lovely money and practically none will do otherwise, despite any ethical considerations. I also know how corrupt police are now and know that what Bob Bottom published a long time ago in one of his books on corruption is true.

Bob said to me quite some years ago : "Uniquely in Queensland, there is a symbiotic relationship between the corrupt police IN the drug trade and the paedophiles." I now know that this is true, but now, in all States of Australia.
